PIIOP 2013/14 project

Data collection for the next stage of the PIIOP works commenced this week. Murray Irrigation has commenced survey work along our channels in Divisions 3 to 8 (east of Deniliquin) and Division 16 (west of Deniliquin). The data collection, which includes survey work, will be completed by a combination of Murray Irrigation staff and contractors appointed by Murray Irrigation. It will involve taking measurements of regulators, bridges and outlets along our supply channels in each of these divisions. The work is expected to take approximately eight weeks to complete.

Planning is underway for customer consultation to commence in these Divisions, with customer meetings currently being scheduled for Divisions 3, 8 and 16 in the first week of July and for Divisions 4, 5, 6 and 7 in early-September. These customers will receive further details in the coming weeks.

The investment under PIIOP will allow Murray Irrigation to shift to a remotely controlled or automated system, which will improve the irrigation service to customers.

DE trade and the casual usage fee

Customers whose water use exceeds 120 percent of their delivery entitlements can either pay the casual usage fee or purchase delivery entitlements on the annual market to avoid being charged this fee.

We refer customers in this situation to the detailed information provided at the request of the Southern Riverina Irrigators' (SRI) Chairman Denis Tinkler in *Talking Water* on Tuesday 9 April.

Customers need to assess their own situation to establish whether it is more cost effective for them to purchase delivery entitlements or pay the casual usage fee.

The casual usage fee applies when water use exceeds 120 percent of delivery entitlements held by the customer. Each delivery entitlement provides for 1.2ML of water use at the standard usage charge.

External allocation transfers to or from Murray Irrigation must be lodged **no later than 5.00pm Thursday 30 May** to allow processing before State Water's deadline.
