End of irrigation season planning

Due to the current dry conditions and high irrigation demand, Murray Irrigation has delayed the closing of its Mulwala and Wakool Canal offtakes to 8.00am on Monday 9 May. Orders should be placed by Friday 29 April to ensure delivery. Customers must speak to their Channel Attendant to discuss watering intentions for the remainder of the season (including storage and farm dams for stock and domestic) so Murray Irrigation can plan end of season arrangements, including commencement of PIIOP construction works.

Channels will be progressively drained over the next three weeks where no irrigation intentions have been indicated.

All customers must have watering programs finalised by Monday 9 May. Murray Irrigation cannot guarantee supply after this date. Further details regarding off-allocation will be in *Talking Water*.

Regulator Winter Works Program

As part of Murray Irrigation's PIIOP project, there have been 290 regulator sites upgraded to the new Rubicon gate technology (out of a total of 580). During this winter's non-irrigation period, we are targeting a further 160 sites to be upgraded. These sites are located across the Murray Irrigation network (both east and west). A primary target is to complete all major in-channel sites, which can only be worked on once channels are drained.

No allocation increase

DPI Water announced on Friday no increase to general security entitlements allocation. As a result, Murray Irrigation's general security (Class C) allocation remains at 23 percent. The announcement also included an update of the water availability outlook for 2016/17. To access the announcement, see the 'Water Resources Updates' section of our website. Allocation updates for the final months of 2015/16 will be mid-month only.
